How can I green my church?

Environmental measures can easily be incorporated into all aspects of church life:

1) Spiritual ~

- Include a prayer for the environment in every Mass/church service
- Make regular references to the need to care for God's Creation in sermons
- Celebrate Creation Time from 1st Sept to 4th October every year

2) Practical ~

- Reduce, reuse, recycle & compost
- Use LED light bulbs & reduce thermostat
- Use eco-friendly cleaning materials
- Support and promote Fairtrade

3) Community ~

Connect with members of your local community by inviting them along to hear an environmental speaker or watch an eco-themed film. You could also organise litter picks, nature walks or tree/bulb-planting in your local area

4) Global ~

Support the work of a development agency working in countries where people are already impacted by climate change e.g. Trócaire, Christian Aid, Tearfund, Concern, VITA
